Agriculture in the Community Grant

The Knox County Farm Bureau Foundation is proud to announce the creation of the Agriculture in the Community Grant! In 2022, the Knox County Farm Bureau Foundation adapted a new Mission Statement, "sustaining and promoting the growth of agriculture in Knox County through education and philanthropy." The Foundation has also done strategic planning with a goal of offering community grants to further the agriculture industry. These grants are available to teachers, FFA Chapters & 4-H Clubs, and community groups wanting to signify the importance of agriculture in Knox County.

Teachers- have a lesson idea that goes beyond the usual Ag in the Classroom curriculum?

FFA Chapters & 4-H Clubs- have a field trip idea that would improve groups members knowledge of agriculture? Community Groups- have an idea that brings agriculture to the community?

Grant Guidelines:

- Grant proposals will be accepted 4 times throughout the year on the 1st of February, May, August, and November.
- Grant applications must be submitted on the application form.
- The audience of the project must include a majority of Knox County/Knox County residents.
- The recipients of the grants will be chosen based on the above criteria and guidelines along with the answers to the questions. Some applications may not be funded.
- One project may be submitted at a time per quarter.
- The grant funds may not cover all expenses related to the project.
- Projects that have a lasting impact will be favored over those with a short-term impact.
- A final report will have to be submitted within three months of completion of project.
- Publicity of the project will be coordinated with the Knox County Farm Bureau Executive Director.
- Additional information may be requested to verify the organization status.

A Look Back- Grain Bin Rescue Equipment Donation

In 2022, the Knox County Farm Bureau Foundation was approached to help fund a grain bin rescue equipment trailer. With the help of the Galesburg Community Foundation, \$20,000 was awarded to the Oneida-Wataga Fire Protection District for a Knox County Grain Bin Rescue Equipment Trailer. Galesburg Community Foundation provided the Knox County Farm Bureau Foundation with a matching \$10,000 grant. The 7 foot by 16 foot trailer will contain ropes, webbing, hand tools, ladder, personal protective gear, and a grain rescue tube. Western Grain Marketing donated the auger that is used to evacuate the grain from inside the rescue tube. Along with the rescue trailer, volunteer firefighters have to go through a 40 hour Grain Bin Rescue and Recovery Operations training to be part of the certified Knox County Rescue team. Below, are pictures of the Knox County Grain Bin Rescue Trailer. While we hope the equipment never has to be used, we are thankful to have this equipment locally. This is one of the Foundation's biggest donations, but the impact will be made for years!
