## Yoder Named Illinois Farm Bureau Young Leader **Discussion Meet Winner**

CHICAGO — Tara Yoder of Knox County was named the Young Leader discussion meet winner at the annual meeting of the Illinois Farm Bureau (IFB) in Chicago, Dec. 5-8.

In addition to receiving a trophy, Yoder will receive two months of use or 100 hours of use of a Massey-Ferguson tractor, compliments of AGCO, and \$2,500 cash from the IFB. She also will receive expense-paid trips to the 2016 American Farm Bureau Federation Annual Meeting, 2016 GROWMARK Annual Meeting, courtesy of GROWMARK, Inc., the 2016 American Farm Bureau Federation Young Farmer and Rancher Conference and the 2016 IFB state Young Leader Conference.

Yoder, who is in her final year of eligibility for the IFB Young Leader discussion meet, encouraged other young farmers to get involved early so they get a taste of the activities and how the discussion meet works.

"The discussion meet was one of the things I always wanted to do, but didn't know if I would be competitive,' Yoder said. "But, I've been involved in consumer advocacy and legislative outreach and the discussion meet ties it all together.

Yoder said she enjoyed meeting all the contestants and having the opportunity to discuss today's most important agricultural issues with farmers from different backgrounds.

"I really enjoyed the different perspectives everyone brought to the table," Yoder said. "Being able to collaborate, discuss and come up with different solutions for different problems was a great experience because, being involved in the dairy industry, I don't always get to discuss a lot of these

contestants' ability to manage a small group discussion. Each contestant gives an opening statement. Participants exchange facts and insights on a predetermined topic. Judges award points based on how well participants work with one another, how well they express themselves, and on their knowledge of the topic.

Topics for the 2015 discussion meet included a discussion on how Farm Bureau should protect and encourage producers' ability to use new technology and how the organization can work with government and the public to ensure public acceptance while encouraging innovations; whether Farm Bureau should draft policy to protect livestock producers from false accusations regarding animal welfare; how to balance agriculture's water needs with maintaining vibrant communities and how historical water rights influence the discussion; how Farm Bureau could get the public to support right-to-farm laws and if those laws should be determined on the state or federal level; and how young farmers can influence state and local policy that more effectively balances the social and economic interests of farmers and ranchers versus burdensome federal regulation.

Twenty-four district winners vied for the title of state winner during the IFB annual meeting.

Yoder said she's looking forward to representing Illinois in the national Young Farmer and Rancher Discussion Meet at the AFBF annual meeting in January.

"It's still very surreal — I really didn't expect to make it past the first round," Yoder said. "But I'm very excited to go to the national level. I like the fact that the questions are the same because different parts or topics of the questions

#### Illinois Farm Bureau members set policy, elect new officers during annual meeting

As the Illinois Farm Bureau (IFB) looks toward 2016 to celebrate its 100th anniversary, delegates to the 101st IFB Annual Meeting celebrated one of its longest-lasting traditions: grassroots, member-driven decision making to set the organization's policy for the coming year.

One of the most important actions the delegate body took was to pass their sense of the delegate body resolutions, one of which dealt with the importance of the Illinois General Assembly, governor and legislative leaders to get a state budget completed for fiscal year 2016.

"Many agricultural entities have been negatively impacted by the lack of a state budget," said Mark Gebhards, director, Governmental Affairs and Commodities, IFB. "We know that Soil and Water Conservation Districts, University of Illinois Extension Service, and county fairs have all felt the negative impacts of not having a budget in place. The delegate body simply wanted to send a message - a strong message — to get this budget done as soon as possible and that certainly was conveyed through that sense of the delegate body resolution.

Delegates also focused their energy on several important resolutions, including property rights, renewable fuels, local government, transportation and nutrient management.

"Property rights have been one of the core principles that the IFB has included in the policy book for many, many years," Gebhards said. "And it's important now because of the multitude of utility projects either underway or proposed in the state of Illinois. The resolution focused on making sure that the Illinois Department of Agriculture has the enforcing ability that it needs to enforce the ag mitigation agreements that the companies would enter into and the Illinois Department of Agriculture would enforce on behalf of

said. "The delegates were interested in making sure that IFB looks for all opportunities to use renewable fuels, whether that means flex fuel vehicles, or various state agencies and federal agencies using that renewable fuel as part of their day-to-day operation."

Delegates also debated the need for a reduction in units of local government, transportation and funding for infrastructure, and the need to follow the Illinois Nutrient Loss Reduction Strategy. To finish the delegate business, the delegates reelected President Richard Guebert, Jr., of Ellis Grove, and Vice

President David Erickson, of Altona. Delegates also confirmed the election of four new members of the IFB Board of Directors. Michele Aavang of McHenry County was elected to a two-year term to represent District 1, Jeff Kirwan of Mercer County was elected to a twoyear term to represent District 3, Tamara D. Halterman of Grundy County was elected to a two-year term to represent District 5, and Troy Uphoff of Shelby County was elected to a two-year term to represent District 11.

#### Filing farm office memories

I remember my delight when Granny let me pencil in feed, fuel and a few other farm expenses on the large paper spreadsheet on her desk. Good thing for the No. 2 lead with Granny's signature pencil top eraser – in case she found a mistake upon review of her young granddaughter's work. But boy, I felt important seated in Granny's rolling chair at her steel-framed desk in her farmhouse office.

As much as picking corn, baling straw and checking cattle threaded through my childhood memories, so did encounters with bookwork and office tasks. This exposure ranks one of the advantages of self-employment: The kids see their parents at work and even work alongside them at appropriate tasks. In fact, we frequently honor the "Take Our Daughters and Sons to Work Day," otherwise recognized in April.

The youngest generation on the farm gains exposure to a mass of paperwork and electronic record-keeping that has evolved in intensity for each generation of our farm family. They witness the concentration of this month's 1099s, the necessity of government documents and the significance of thorough harvest records for insurance reporting. They learn work ethic, yet realize how to incorporate family time when work perpetually surrounds us. In fact, their day typically starts with a beeline to my home office to greet me and cuddle in my office chair.

Just ahead of Thanksgiving, my kids hopped off the bus at the farm and entered our new family farm office to find several desks installed that day. To my surprise, they acted more thrilled than a kid with a pedal tractor on a wide-open shop floor. They pretended to type on the computers and gather paper from the printer. Our daughter made imaginary copies with the copy machine, and our son used post-it notepads to record fake phone numbers.

"It's cool to play office," he says.

#### Not on days of splitting out shares of our farm's self-applied crop protection products. Other than that, I like it, too.

As a kid, I probably put a few office supplies on my Christmas list. Tape dispensers were neat. A stapler in my stocking would have rated just fine. Now, I can't do without electronic spreadsheets, my smartphone and constant internet access for farm bookwork. I have always enjoyed desks, office gadgets, desk-type duties and the potential organization that accompanied them. I inherited some of that intrigue. I remember Mom's excitement when she received a roll-top oak desk for her 30th birthday. Unfortunately, its size now proves too small for the magnitude of farm books and impractical for the mandatory computer access.

Meanwhile, the kids find unique fun in this work environment, too, including at Granny's farmhouse office of my childhood. With a nickel from Great Gramps' center desk drawer, the kids can buy enough M&Ms from her retailstyle candy dispenser to fill an old Altoids tin. Likewise, they fill their hearts with memories to file away and revisit another day.

and Illinois Farm Bureau® (IFB) members and their children may apply for college scholarships offered by the IAA Foundation, Illinois Farm Bureau's charitable arm. Sixty six scholarships, ranging from \$1,000 to \$7,500 per year, will be awarded in total of \$118,500 for the 2016-2017 school year.

"We are pleased to help students through our growing scholarship program, which offers a wide variety of support to farm families, and to those pursuing careers in agriculture " said Susan Moore, director, IAA Foundation. "It is a great privilege to support our next generation of leaders, and encourage continuing education in agricultural fields."

Students may apply for a variety of scholarships, including three IAA Foundation Top Scholarships, where winners will each receive \$5,000 awards. Another \$7,500 award goes to the Illinois Farm Bureau Legacy of Leadership scholarship winner.

New this year, the Dwain Ford Memorial Soybean Scholarship was established by colleagues, friends and family to honor soybean industry, and offers a \$1,000 award to an ag student active in 4-H and FFA.

Students studying crop science and pursuing a masters degree related to research are eligible for the Illinois Soybean Association Crop Science Scholarships. Five \$4,000 scholarship will be awarded to junior level majors. Recipients are then eligible for an additional \$4,000 in this renewable program, providing a total of \$8,000 for his or her junior and senior year of college.

Twenty five \$1,200 scholarships are available to students from specific southern Illinois counties as part of the Dorothy and Wilhelmine Ratermann Memorial Scholarships.

Twelve Prairie Farms Dairy scholarships each worth \$2,000 are available to patrons and employees of the company. An additional two \$1,000 scholarships are available to producers affiliated with the St. Louis District Dairy Council.

Additional scholarships, ranging from \$1,000 to \$1,500, are available to students

of study, place of residence, previous 4-H experience and college or university attended.

All applicants must be high school seniors accepted for enrollment or students already enrolled at an accredited college, university or community college. Scholarships are awarded for exceptional academic ability, leadership and financial need. Previous winners of an IAA Foundation scholarship are eligible to apply again.

#### Use Caution This Winter When Using Space Heaters

With home heating costs on the rise this winter, many people are turning to alternate heating sources to keep costs down. If you plan to use space heaters this winter, use extreme caution.

According to the National Fire Protection Association (NFPA), portable and fixed space heaters caused a disproportionate share of home heating fire deaths in 2007. Space heaters were involved in 32 percent of home heating fires, but 79 percent of the deaths. In addition, heating equipment was responsible for \$608 million in property damage.

How To Choose The Right Space Heater Select a space heater with a guard around the

flame area or heating element to protect children and clothing. Choose a heater that has been certified by a

nationally recognized testing laboratory such as Underwriters Laboratories (UĽ).

Buy a heater that is the correct size for the area you want to heat. The wrong size heater could produce more pollutants and may not be an efficient use of energy.

Read and follow the manufacturer's operating instructions, and make sure all members of the household understand how to operate the heater safely.

Make sure the heater has an automatic "tipswitch," a cutoff device that turns off electric or kerosene heaters if they tip over.

**How To Prevent Space Heater Fires** Place the heater on a level, hard, noncombustible

#### January is Cervical Cancer Awareness Month

Approximatly 11,000 American women will learn they have cervical cancer this year. This January, during Cervical Cancer Awareness Month. The Knox County Helath Department is focused on educating women about how important it is to receive a Pap test as a screening tool for cervical cancer/human papillomavirus and about vaccines that can further reduce the burden of this devastating disease.

It's the start of a new year – a time many women reflect on their health. To start the year right, we encourage women to contact the Knox County Health Department or their health care provider to schedule a Pap test to check for cervical cancer. This screening is a crucial part of a woman's health care regimen, yet one that many overlook. It's important to remember that cervical cancer is a preventable disease – as long as it's caught early enough.

While routine Pap tests are the best means of detecting cervical cancer at an early stage, vaccines have the potential to protect women from the disease, be targeting cancer-causing types of the HPV. In girls and young women ages 9 to 26, Gardasil helps protect against 2 types of HPV that cause about 75% of cervical cancer cases, and 2 more types that cause 90% of genital warts cases. However, the vaccine is not recommended for all women, and KCHD officials stress that it does not prevent all strains of HPV or eliminate the need for annual Pap tests, gynecological exams that screen for cervical cancer.

"A Pap test is one of the most important health tools for women to prevent cervical cancer," said Director of Family Health, Heather Kusler. "To maintain good health throughout the course of our lives, we must practice prevention. Doing things like avoiding tobacco, following a healthy diet and getting regular exercise are important, but it's also important to stay up-to-date on vaccines and get regular health screenings that detect disease."

The Pap test, also called a Pap smear, screens for abnormal cells in the cervix that may lead to cancer if not treated. The screening is done in a doctor's office or clinic and only takes a few minutes. Results of the test are usually ready within a few days. If the results of the Pap test show abnormal cells that could become cancerous, numerous treatment options are available to remove the abnormal cells. In most cases, the treatment prevents cervical cancer from developing.

"Cervical cancer remains a serious threat to women's health despite the development of the HPV vaccine and early detection tools," Kusler states. "Fortunately, the Illinois Breast and Cervical Cancer Program can provide breast and cervical cancer screenings to eligible women between the ages of 35-64 that reside in Knox, Warren or Henderson Counties. This program can assist women who do not have insurance or may have limited insurance access these services. to Please contact us at the Knox County Health Department at 309-344-2224 or visit www.knoxcountyhealth.org, to see if the Illinois Breast and Cervical Cancer Program (IBCCP) can be of assistance. If more women have access to care, we can reduce the rates of cervical cancer."

We are getting reports that many of the oats went into the bins in only fair condition and as a result there has been some musty oats, lots of weevil which may affect the germination. We suggest that you make a germination test of your oats before planning to use them for seed or sell them. Be sure and get germination test before having your oats cleaned. Last year one farmer had 200 bushels of oats cleaned and later found out that they had only a 30% germination. It looks now like good seed oats might be a scarce. With farm costs raising faster than farm income, your best chance to earn a profit, your best chance to earn a profit in 1952 is still efficient production.
