#### FFA blue jacket delivers lifetime impact

I have an FFA sticker on my phone, an "FFA Bed" in our loft and the beat of blue and gold in my heart. My son quickly points out my FFA Mom t-shirt as an example of my FFA fascination, but I also own a navy blazer with gold blouse and FFA lapel pin.

I love FFA, and I'm proud to show it.

FFA done well transforms lives. Likewise, agriculture programs with good teachers bring notice to the often-unnoticed teens. Immeasurable satisfaction swells within me and every one of our passionate volunteers who witness this national youth organization use agriculture as the avenue to develop young leaders, spark career interests, connect classroom learning to competitions, and provide conference and convention opportunities unlike any other school organization.

FFA is our family's sport, a competitive and disciplined organization with its own uniform. It is uniquely inter-curricular not extra-curricular as FFA weaves into agricultural education curriculum at the 7-12 grade level. Often, membership generates an incredible everlasting loyalty, adoration and allegiance that keeps the signature corduroy jackets in our closets decades past wearing

Through my two kids, our chapter's members and our FFA Alumni group, I'm gaining more from the blue jacket today than when I wore it. Our son leads quietly, a servant leader with a stellar record book in his passion for ag mechanics. My daughter just finished her term as the first major state officer in 60 years from our tiny school's FFA Chapter.

The high-profile privilege came with responsibility, never complacency. She deferred college for a year to serve and travel more than 20,000 miles in-state to advocate for agriculture, vocational education and FFA. She commonly worked 60-hour weeks,

sometimes more, with her teammates. They led thousands of students at workshops and conferences with record-breaking attendance. The team traveled to D.C. twice in 12 months and conversed with nearly 30 legislators representing Illinois. Each state officer visited almost 100 high schools in the fall alone and delivered more than 25 speeches across the term.

Our daughter found inspiration in the people she met, was challenged by the demands of leadership and humbly accepted the constant requirement to perform in public and leave an impact. Through exhaustion, challenge, triumph, criticism and praise, she grew more personally and professionally in the last 12 months than I will in my lifetime.

I took photos or videos almost every weekend when the FFA-wrapped Bronco she drove during the term left our driveway. Eventually, I'll hang a photo of it near our "FFA Bed," a spare queen topped with navy linens and gold throw pillows to accommodate FFA state officer guests.

My drive to support FFA will never rest.

# Getting To Know Your Farm Bureau Policy

123. TRANSPORTATION

#### We support:

- 1. Development of a long-range national transportation policy.
- 2. A system serving the needs of both passengers and freight across the country.
- 3. Exploration of public-private partnerships.
- 4. Developing economical and energy efficient methods of meeting future transportation needs and global competitiveness.

#### Land Use

#### We support:

1. Regulations which:

- A. Provide improved noxious weed and brush control by state and local road authorities on the full width of highway rights-of-way.
  - B. Maintain safe levels of visibility.
- C. Protect farmers' crops from unwarranted or careless spraying.
- D. Ensure that ditch and roadside vegetation maintenance practices do not impair drainage to or from adjoining farm fields.
- E. Preserve vegetative cover adequate to prevent soil erosion on roadsides and in ditches.
- 2. Enforcement of noxious weed and brush control by railroad authorities on railroad rights of-way, including the use of a soil conserving cover crop whether the railroad is in operation or abandoned.
  - 3. Giving counties the power to levy a

fine of \$500 per acre of railroad rights-ofway where noxious weeds are not eradicated or controlled.

- 4. Enforcement of drainage laws and regulations on railroad rights-of-way.
- 5. Oversight of railroad construction projects and design standards by appropriate government agencies to minimize disturbance to adjoining farmland and farming operations and to adequately protect or repair drainage and drainage systems.
- 6. Efforts to ensure that highway construction and improvement projects do not cause serious, adverse impact to drainage nor cause erosion on adjacent land.
- 7. Utilization of marginal farmland or poorer grades of land for new railroad or highway construction projects where feasible in order to preserve tillable farm-
- 8. Utilization of existing rights-of-way for new highways to the maximum extent feasible in order to minimize acquisition of new lands for highway purposes.
- 9. Equitable compensation to landowners for disruption of farming operations by highway construction.

#### Other

#### We support:

- 1. Efficient mass transportation. We will support legislation or regulations to allow disconnection of counties by referendum from mass transportation authorities.
- 2. Use of biodiesel and ethanol by mass transit systems.
  - 3. Efforts to streamline the transporta-

tion project delivery process to reduce unnecessary time delays including:

- A. Simplifying the environmental process for projects with few impacts.
- B. Involving appropriate reviewing agencies early in the process to help expedite overall project schedules.
- C. Requiring greater coordination among federal reviewing agencies and setting time limits for their review.
- D. Use of the Design-Build project delivery method or other innovative construction strategies.
- 4. Efforts to educate policy makers and the public to ensure they understand:
- A. The value and necessity of efficient and effective transportation infrastruc-
- B. The complexity and cost of both long-term maintenance and expansion of transportation infrastructure to meet future needs.
- C. The importance of interconnectivity between modes.
- D. Requiring construction projects to be completed as timely and safely as possible, minimizing impacts on the traveling
- 5. The removal of concrete bridges on township roads with less than 20 feet clearance widths and banister heights taller than 18 inches from the register of historic places so they can be replaced with a new bridge that allows modern farm implements to easily pass over them.



# **Knox Community Health Center Celebrates National Health Center Week**

America's Health Centers Celebrating 60 Years of Improving Our Nation's Health

The Knox Community Health Center (KCHC) celebrated National Health Center Week (NHCW) 2025 August 3-9. The annual event highlights the essential role Community Health Centers (CHCs) play in improving public health and providing Americans equal opportunity to access critical healthcare services. CHCs represent the nation's largest primary care network, serving 32.5 million patients nationwide.

Located at 1361 W. Fremont St. in Galesburg, KCHC offers medical, dental, and behavioral health services. The center is open Monday through Friday 7 a.m. to 5 p.m. Appointments can be made by calling 309-344-2225.

The KCHC medical team is led by Robert Wagner, MD, who has 59 years of experience and is dedicated to delivering top-quality care to patients of all ages. The health center offers same-day medical appointments and accepts walk-ins for acute illnesses.

Addressing the need for better access to mental health care, the Knox Community Health Center welcomed Benjamin Clark, Psychiatric Mental Health Nurse Practitioner – Board Certified (PMHNP-BC), to its roster in 2024. The role of the PMHNP-BC is to assess, diagnose and provide treatment for mental health needs. Clark is accepting new patients and does not require a referral to make an appointment.

The Knox Community Health Center provides comprehensive healthcare services to patients regardless of income or insurance status. KCHC accepts a wide range of insurance plans including most private insurance, Medicare, and Medicaid (including MCO's). For uninsured or underinsured patients, the Knox Community Health Center offers a sliding fee scale based on household income. Additionally, eligible KCHC patients can participate in the 340b prescription drug program to obtain affordable medications.

KCHC also employs certified health insurance Navigators to assist the community with

applying for Marketplace health insurance and Medicaid at no cost to the applicant. Currently Marketplace health insurance is in Special Enrollment Period for those with a life changing event that caused them to lose their health insurance in the past 60 days. Open Enrollment begins November 1<sup>st</sup>.

This year's NHCW celebration, launched by the National Association of Community Health Centers (NACHC), focused on the theme: "America's Health Centers Celebrating 60 Years of Improving our Nation's Health." 

### Recipe of the Month **Baked Club Sliders**

#### **Ingredients**

- 24 Hawaiian rolls or slider buns
- ½ cup mayonnaise
- 2 pounds thin sliced turkey 2 pounds thin sliced ham
- 14 slices bacon
- 12 slices provolone cheese cut int half
- 1 cup butter
- 3 tablespoons spicy brown mustard
- 2 teaspoons onion powder
- 2 tablespoons Worcestershire sauce
- ½ teaspoon granulated sugar
- 1 tablespoon poppy seeds



#### **Instructions**

- Preheat oven to 350 degrees F. Grab a 9-inch x 13-inch pan and an 8-inch x 8-inch pan OR an oversized baking dish for these sliders.
- Cook bacon on the stovetop or in the oven.
- Slice rolls in half to create a set of tops and bottoms. Place bottom halves into pans and spread with mayo.
- Layer bottom buns with turkey, ham, bacon (breaking it into pieces to fit as needed), and then half slices of cheese. Each layer should cover the previous layer edge to edge. Place top buns over the filling.
- In a medium bowl, melt butter. Mix in mustard, onion powder, Worcestershire sauce, sugar, and poppy seeds. Brush butter mixture over the rolls or pour it evenly all over the
- At this point, you can get baking OR cover sandwiches with plastic wrap and store them in the fridge until ready to serve.
- Bake sliders for 15-18 minutes until cheese is melted and rolls are golden on top.
- Remove from oven and let cool for 5 minutes before cutting into individual sliders. Serve warm


